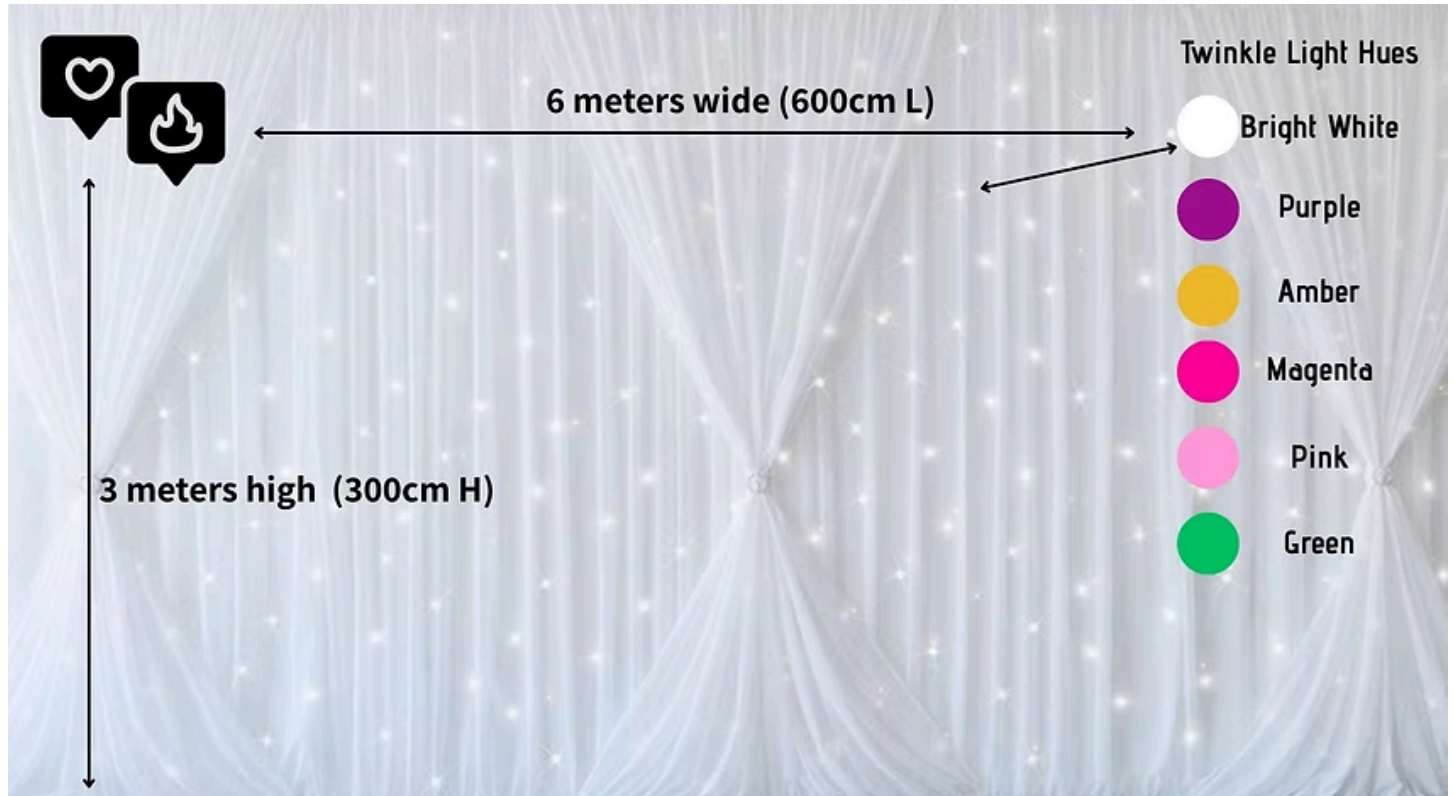


# Dry Hire Terms & Conditions

## [Loch Lomond Balloons](#)

These terms apply to all dry hire items supplied by **Loch Lomond Balloons**.

By booking, paying a deposit, or collecting the hire items, you agree to the terms below.



## 1. The Hire Items

The hire includes the items listed on your booking or invoice (for example: fibre optic backdrops, twinkle light curtains, frames, cables and accessories).

All equipment remains the property of [Loch Lomond Balloons](#) at all times.

## 2. Hire Period

- The hire period starts from the **agreed collection time**
- The hire period ends at the **agreed return time**
- Late returns may result in an additional charge

You are responsible for the items from the moment they are collected until they are returned.

## 3. Using the Equipment

You agree to:

- Use the equipment **indoors or fully undercover only**, unless agreed in advance

- Use the items only for their intended purpose
- Keep equipment away from water, heat, candles, naked flames and heaters
- Ensure children do not play with the equipment or cables

You must **not**:

- Alter, cut, tape, repair or modify the equipment
- Pull, knot, sharply bend or tangle fibre optic strands or lights

## 4. Care & Responsibility

Please treat all items with care.

You are fully responsible for any **loss, theft or damage**, no matter how it happens, during the hire period.

## 5. Damage, Loss & Cleaning

All items must be returned:

- Clean
- Dry
- Untangled
- In working order

You may be charged for:

- Damage requiring repair
- Full replacement if items are lost, stolen or beyond repair
- Extra cleaning if items are returned dirty

Any costs will be assessed by **Loch Lomond Balloons** and charged accordingly.

## 6. Electrical Equipment

- All electrical items are PAT tested
- You must provide a safe, standard power supply
- Equipment must not be used in wet or unsafe conditions

We cannot be held responsible for power cuts or venue electrical faults.

## 7. Cancellations

- Cancellations must be made in writing
- Cancellation charges may apply depending on notice given
- Deposits are non-refundable unless stated otherwise

## 8. Liability

- **Loch Lomond Balloons** is not responsible for injury or damage caused by misuse of the equipment
- You accept responsibility for any injury or damage caused while the items are on hire
- We are not liable for circumstances outside our control (such as venue restrictions or power failure)

## 9. Collection & Return

- Please check all items when collecting
- Any issues must be reported immediately
- Problems reported after the event cannot be accepted

All items must be returned at the agreed time and in the condition received.

## 10. Service Area

Dry hire services are available to customers across **Greater Glasgow and surrounding areas.**

## 11. Agreement
